

Easter Kids Poster Competition – Terms and Conditions

- 1- The competition is being run by Zero Carbon Harrogate, (Charity Number 1192634).
- 2- The competition is open to residents of the United Kingdom aged 11 years or under. All entries must be made by a parent/guardian aged 18 or over, on behalf of the child. Any entries/data received directly from the child will not be accepted and all data will be immediately deleted.
- 3- There is no entry fee and no purchase necessary to enter this competition.
- 4- By entering this competition, an entrant and their parent/guardian is indicating his/her agreement to be bound by these terms and conditions.

- 6- Only one entry will be accepted per child. Multiple entries from the same child will be disqualified.
- 7- Entries from different children in the same household will be accepted.
- 8- The competition starts on Sunday March 28th 2021. **The closing date for entry will be midnight on Sunday April 11th 2021**. After this date no further entries to the competition will be permitted.
- 9- No responsibility can be accepted for entries not received for whatever reason.

 - The child will produce a poster to show how and why we should reduce our carbon footprint.
 - Any materials used to create the poster are acceptable (e.g., card, paper, tissue paper, colouring pencils, etc.). It is the parent's responsibility to ensure that the child creates the poster in a safe way using age-appropriate resources and must be supervised at all times. The parent may help the child use tools such as scissors and glue if necessary, to produce the child's desired design.
 - The parent/guardian will then take a photo of the artwork only (no children should be in the photo). Please try to ensure the whole poster is shown within the photo and is taken with good lighting.
 - The parent/guardian will then email the photo to comp.zch@gmail.com and supply the following information:
 - Parent's/guardian's name
 - o Child's age



- The emailed photo should be sent at the highest quality possible to ensure all poster artwork is clearly visible.
- 11- By entering this competition the parent/guardian agrees that Zero Carbon Harrogate can share the image of the poster freely in any publicity material, including on Zero Carbon Harrogate's social media pages. This does not include sharing the child's name/age. In order for Zero Carbon Harrogate to include the age and name of the child who created the poster, Zero Carbon Harrogate will seek permission first, in writing via email.
- 12- Any personal data relating to the winner or any other entrants will be used solely in accordance with current UK data protection legislation and will not be disclosed to a third party without the entrant's prior consent.
